

A national survey conducted by CCCEP in 2022 revealed that most pharmacy professionals perceived accredited learning to be of **higher quality**, **evidence based**, and **unbiased**, as shown in the table below.

Our 2022 survey also highlighted the need for more accredited pharmacy continuing education. With the **high number of pharmacy professionals in Canada**, there are significant opportunities for continuing education providers to develop a wider range of accredited learning resources – particularly for pharmacy technicians.

Our survey revealed some significant gaps in existing pharmacy continuing education. When asked what topics were missing from the available accredited learning opportunities, **leadership and management**, **mental health**, and **oncology** were frequently mentioned by **pharmacists**. Meanwhile, **pharmacy technicians** noted an overall lack of technician-focused content and expressed interest in a diverse range of topics, with **compounding learning opportunities** being the most demanded.
